Introduction

SAVERA is a Non-Governmental Organization, was founded on September 23, 2000 with a few likeminded enthusiastic and committed personalities from various walks of life including academicians, journalists, social activists with main objective to promote holistic development of the marginalized and vulnerable communities, particularly those who stayed behind, neglected, exploited and unable to educate themselves in the rural areas of Bihar, Uttar Pradesh, Uttarakhand, Jharkhand, West Bengal, Odisha, Delhi and Himachal Pradesh.

SAVERA is registered under Societies Registration Act XXI of 1860 from GNCT of Delhi with all India Level and also registered under Section 12AA & 80G of Income Tax Act from Govt. of India.

SAVERA believes that improvement of under-developed and under-privileged rural communities is largely related with augmenting the capability of vulnerable groups of rural society like women, scheduled caste/tribes, poor students and other marginal groups. Knowing the fact that most of these groups are uneducated, unaware of their legal and constitutional rights and are living in the most destitute conditions, we had to focus on two resolutions (i) educating of rural people about their social, economic and political rights and (ii) bringing positive and long changes in the lives of rural people through implementing various socio-economic welfare programmes.

In past 22 years, SAVERA is involved in various types of educational and awareness programs, socio-economic welfare programs and also imparting new ideas through knowledge based empirical research, surveys & innovation on various socio-

economic issues. SAVERA is primarily working in the field of Health & Family Welfare, Consumer Protection and Consumer Welfare, Micro finance (SHGs), Housing and Poverty Alleviation, Livelihood Programme, Agriculture, Animal Husbandry and Environment & Sustainable Development.

Being a grassroots level organisation and having vast experience in implementation of various Government and CSR projects, SAVERA works in close collaboration with Central and State Govt. departments at different level and also involved in CSR Schemes of several PSUs like REC, NTPC, GAIL, HPCL, ONGC, BPCL, Ujjivan Small Finance Bank Limited etc. The organization is actively involved in area of regeneration of traditional industries through various approaches for its sustainable development and create sustainable livelihood.

Objectives

The broad objectives of SAVERA is to enable the under privileged population of the society especially in Rural Area to attain in self-reliance in their social and economic development and to create awareness and empower. Safe Drinking Water Phase II: Installation of 200 RO Plant in Primary Schools

The REC, under its CSR scheme had sanctioned financial contribution of 1.01 crore on 28th February, 2020 for installation of 200 RO water treatment plant with 500-liter overhead storage tank and 1 HP Electrical Pump at 100 Anganwadi Centres and 100 Primary Schools in Purnea district of Bihar to implementing agency Society for Advancement of Villagers Empowerment and Rehabilitation of All (SAVERA) to implement within 18 months in two phases from the date of sanction. The first phase was completed in December, 2021 under which installation was done at Anganwadi Centre while 2nd Phase of the project was started in January, 2022 to install RO Treatment plant in Primary Schools.

Installation of 200 RO Machine (100 in Aanganwadi Kendra and 100 Primary schools is funded by REC Foundation, New Delhi and the implementation of the project to be done by SAVERA, New Delhi) in Purnea district, Bihar





Objective of the Project

1. To improve access to safe drinking water for children
2. To focus on raising awareness and changing behavior around WASH (water, sanitation and Hygiene) related issue among children.
3. To facilitate capacity building of staff of Anganwadi Kendra/ Primary schools

Awareness and Training Programmes on Safe Drinking Water

Under the project Training for Anganwadi Sevika and other stakeholders were conducted at village level. IEC materials were distributed individually to Sevika, Staffs and panchayat members at the time of installation of RO machine at Anganwadi Centres.

IEC Booklet & Pamphlet

Information, education and communication (IEC) is also an important part to execute the project therefore SAVERA have prepared IEC booklet and Pamphlet on Hygiene and Safe Drinking Water in Hindi language aims at behavior change of the masses to adopt better sanitation practices.

Sevika were enquired by PMR team about what input they got from IEC materials. Sevika and Panchayat members revealed that IEC materials consist of booklet and pamphlet are very useful for them to understand the importance of cleanness. IEC booklet gives immense knowledge to them that how to keep surroundings clean and its significance for health. At the time of installation of RO Machine, a representative of company disseminated detail knowledge about each and every aspect of functioning of RO machine to Anganwadi Sevika who has taken responsibility of look after RO plant.

SFURTI Scheme: Jute & Banana Natural Fiber Cluster Purnea

In aspirational district Purnea, SAVERA as an implementing agency working with Ministry of MSME, Government of India for the development of Jute and Banana Fiber Cluster under the Scheme of Fund for Regeneration of Traditional Agencies (SFURTI). The Common Facility Centre for the same has been established at Uphrali, Purnea. There are 1000 artisans associated with this cluster. This project under SFURTI has sanctioned to SAVERA on 15th July, 2020 to develop Jute and Banana Natural Fiber Cluster Purnea for five years. Under this project various activities performed in 2022.



SFURTI is Scheme of Fund for Regeneration of Traditional Industries. Ministry of Micro Small and Medium Enterprises (MSME), Govt. of India has launched this scheme in the year 2005 with the view to promote Cluster development. The scheme of Ministry of MSME, Government of India envisages development of clusters to:

- (i) provide employment to artisans and entrepreneurs,

- (ii) improve competitiveness through skill and technology enhancement, and
- (iii) improve marketability of products and
- (iv) for their long-term sustainability

Upskilling of Economically Backward Rural Women Artisans

The Project “Upskilling the Rural Artisans, Entrepreneurs and Economically Backward Women, funded by Ujjivan Small Finance Bank Limited was sanctioned to Society for Advancement of Villagers Empowerment and Rehabilitation for All (SAVERA) on 24th March, 2022. The grant provided towards setting up a manufacturing unit and purchasing raw materials to manufacture Jute & Banana Natural Fibre based product as well as upskilling the rural artisan, entrepreneur and economically backward women at establishment of Jute and Banana Natural Fibre Cluster Purnea for 12 months. It was expected to provide livelihood to 50 women artisans as well as indirect livelihood for more than 100 women under this project.



Objectives

The project of Upskilling the Rural Artisans, Entrepreneurs and Economically Backward women under the CSR scheme was sanctioned with following objectives

- To organize the artisans and rural entrepreneur by setting up Jute and Banana Natural Fiber based product manufacturing unit to make them skilled, competitive, available them sustained employment, providing support new products, design intervention, improved packaging and link them with market.
- To Improve socio-economic status of women artisans economically backward background of Purnia.

Under this project a model unit for upskilling artisans and manufacturing natural fiber-based product has been established at Jute and Banana Natural Fiber Common Facilities Centre where 12 Automatic Sewing Machines and 5 Paddle Machines are installed. 15 machines were installed under the grant of Ujjivan Small Finance Bank Limited, while 2 machines were installed by SAVERA under SFURTI scheme.

- In 12 months of intervention under the project 50 women artisans have been directly benefited from the project. They were semi-skilled before induction with project but with engagement in CFC they got upskilled and started in designing and sewing of garment blended with jute and banana fiber.
- As far indirect beneficiary is concerned around 100 artisans have been benefited under this project and now they are engaged in craft making, packaging of product, marketing and other support kind of activities to sustain their livelihood.
- Most of the upskilled artisans are belong to economically backward class. They were not earning before the intervention of Ujjivan Bank supported project. Now it has been recorded they are some respectable amounts out of it.
- With having 17 sewing machines at CFC to engage 50 artisans, 3 artisans per machines were made engage daily on rotational basis.
- Artisans were engaged in manufacturing garment and jute-based products during the training period as raw material of garment was purchased under the grant of by Ujjivan Small Finance Bank Limited.
- Presently average income of artisans is Rs. 6000/ Month when they are engaged on rotational basis with 16 sewing machines. If each artisan gets daily engagement

in manufacturing, then their income would be 12000/ Month and more indirect livelihood to be created.

- Jute and Banana Natural Fiber based product manufacturing has made the artisans skilled, competitive, available them sustained employment, providing support new products, design intervention, improved packaging and link them with market. The following categories of products are being produced by skilled artisans.
